Objectives and investment policy

The Fund aims to preserve capital and provide long term capital growth through investing mainly in the shares of international companies (including UK). The Fund will focus on a small number of investments in companies which the investment manager believes offer good value relative to their long-term potential.

The Fund may also make other investments, including:

- bonds issued by governments and other organisations
- other investment funds
- cash, deposits and money market instruments
- warrants.

The Fund may use derivatives for Efficient Portfolio Management (EPM), i.e. to protect against market or currency movements, to reduce costs, or to earn income or capital.

Net Income Shares: Any income the Fund generates will be paid out to you.

Net Accumulation Shares: Any income the Fund generates will be reinvested.

You can buy and sell shares on any working day in London.

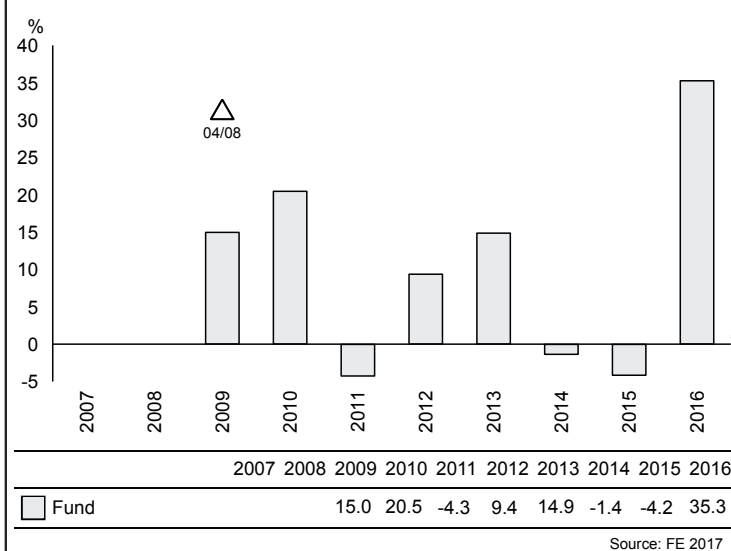
