The Fund rose again this month, up 3.6%. This comes in the face of challenging markets as war has returned to Europe, a bitter tragedy and Kennox is only hoping against hope that it will end imminently. Whilst negative, the market's reaction to the conflict has been relatively muted so far, but the situation only adds further uncertainty to a backdrop already littered with potential headwinds – the return of inflation and the future path of interest rates, expensive assets, excessive leverage, tight energy markets, covid-induced disruptions, to name just a few.

In performance terms, it is not surprising that the portfolio's best performers were the gold miners and Equinor (a unique energy asset on the edge of Europe, domiciled in one of the world's safest jurisdictions). Investors are rediscovering the attractions of safe holdings after chasing riskier assets and leverage for so long. Sky NZ and Texwinca were next largest contributors. Neither stock is particularly obvious as defensive, but represent an indication that markets are attaching increasing weight to steadfastness and valuations, and less to momentum and excitement. That two thirds of the holdings in the portfolio rose in February further illustrates the point.

It was not all smooth sailing of course, and weakest for the Fund over the month were Currys and Quadient. Both are very well positioned in their respective markets, generate strong cash flows and trade at exceptional valuations - less than 8x our assessment of their long-term earnings potential. Markets will remain volatile as investors try to pick their way through the current fog, and returns will not be exclusively and uniformly up. With a focus on quality, price and risk, Kennox looks uniquely well positioned.


