#### PERFORMANCE COMMENTARY

#### The Fund returned 1.3% in May.

The largest two stocks in the portfolio were the two largest positive contributors to performance this month. Newmont was up 14.7% (all performance quoted is measured in sterling). We continue to see Newmont as the blue chip in the sector – it has a broad portfolio of mines in safe jurisdictions, not reliant on any single one asset, and the company has a strong management team and culture focused on a clear strategy. The robustness and stability of Newmont's production is a key advantage: stretching out for decades, as a platform offering growth options, and supporting a progressive dividend policy. This is gaining traction in the marketplace, proving attractive to investors who might not normally have been focused on the mining sector. The shares remain attractive on 16x our view of its Sustainable Earnings, and a forward yield of 3%. The second largest contributor to performance was Quadient, up 11.2%. The company recently released solid results, which showed reasonable growth as well as upgrading guidance for 2021. Alongside the announcement of a new independent director, these results were taken positively by a market that continues to have very low expectations for the company. Quadient is inexpensive, trading at 12x SE.

Coming off after a very strong start to 2021, Western Union held the Fund back the most over the month, down 7.5%. This year the market has focused on the company's strong offering and the growth in its digital channel. This positioning was further highlighted by a deal to put Western Union outlets in every Walmart, continuing the expansion of Western Union's reach and distribution. A 3.5% position in the Fund, we remain comfortable holders. The shares trade at 13x SE, backed up by an attractive yield, 3.8% at current prices.
